<p>FY15 Updates and Wrap Up</p>	<p>The AzNN reminded all FY15 contractors to please complete:</p> <ul style="list-style-type: none"> • SOPRAC survey sent out with the latest AzNN biweekly update • all final FY15 reports ASAP <p>The AzNN is awaiting the arrival of a new ScanTron machine to complete scanning FY15 youth surveys. This may affect reporting deadlines associated with the FY15 youth evaluation. Stay tuned for progress updates.</p>
<p>Evaluation Questions re: Serving Up MyPlate Training</p>	<p>Q: Will there be opportunities in FY16 to provide experiential feedback regarding the curriculum and its evaluation?</p> <p>A: Yes, there are multiple venues for this feedback. Feedback regarding experiences implementing the curriculum can be brought to the Direct Education Subcommittee. Feedback regarding experiences with youth surveys can be brought to the Evaluation Subcommittee. Contractors can use the Semi-Annual Report Narrative to provide feedback on any of these topics, and the Evaluation Team will host an</p>

	end-of-year debrief session for youth survey proctors.
Questions re: Customized Evaluation Frameworks	<p>Q: Does the UANN Pima County framework combine the Garden Kitchen and CHAPS units?</p> <p>A: Yes. The frameworks provided are customized for each contractor and, where applicable, each county as the smallest unit addressed. These frameworks only include the strategies addressed by each county and, in some cases, also eliminate tracks that contractors are not working in within a strategy. Lauren McCullough will provide more specific, by-unit evaluation guidance for the UANN that is beyond the scope of the AzNN.</p>
General Timelines and Expectations re: FY16 Evaluation Training	<p>The latest AzNN biweekly update included the FY16 training and meeting schedule as an attachment. The Semi-Annual Report Narrative (SARN) training took place during Policies and Procedures Training, so the calendar does not include SARN. Those who were not able to attend P&P can soon access the SARN training presentation via the AzNN website, and it will be sent as an attachment with the next biweekly update. FY17 trainings will likely become available next summer.</p> <p>Q: How will evaluation results and recommendations be communicated to contractors?</p> <p>A: Written, end-of-year contractor reports will provide contractors with comprehensive evaluation results, interpretations, and recommendations (as appropriate). In addition, more detailed results and recommendations may be provided for specific evaluation efforts, e.g., completing GO NAPP SAC assessments provides contractors with immediate feedback on site-specific ECE PSEs. Trainings for each evaluation effort will provide more information about whether and how specific evaluation efforts may provide additional information beyond the end-of-year reports.</p>
